

BMW Certified Pre-Owned Limited Warranty Transfer Application

- ✓ **Required:** Copy of documentation evidencing change of ownership and mileage at time of sale.*
 - ✓ **Required:** Notarized Seller Statement (see below) affirming the vehicle is a Certified Pre-Owned vehicle.
 - ✓ **Required:** \$200 warranty transfer fee; check payable to BMW of North America, LLC.
- * Acceptable documentation includes a bill of sale and/or copy of title application.

This vehicle must meet current BMW Certified Pre-Owned guidelines for transfer eligibility:

- **Vehicle must have originally been sold as Certified Pre-Owned on or after January 1, 2014.**
- At time of proposed transfer, the BMW CPO Limited Warranty must be in effect, that is, the vehicle is within age & mileage limits.
- Vehicle must not have been totaled, stolen, exported from the US, or imported to the US from another country.
- The BMW CPO Limited Warranty is only eligible to be transferred from private owner to private owner and transfer must be requested by the Buyer of the CPO vehicle. **Dealership participation is excluded.**
- Transfer application must be submitted by the Certified Pre-Owned Buyer within 60 days of vehicle sale.

BMW of North America, LLC reserves the right to refuse transfer in the case of fraud, abuse, failure to meet transfer guidelines, or if the appropriate documentation is not submitted.
